i) Annual General Body will meet once in a year i.e., in the month of DECEMBER

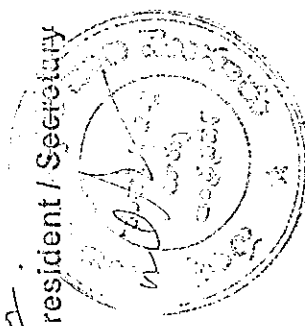
ii) FUNCTIONS:
